Membership Agreement and Release

This Membership Agreement demonstrates how we value our CSA Member Gardeners. We want to assure you that we appreciate your contribution to our organization. We are dedicated to ensuring that you have a quality “CSA Gardener” experience that is both productive and rewarding.

Auro Community Garden, LLC (the “Garden”), located at 4095 Broad St. Brooksville, Fl. and

_____, (the CSA Gardener) agree that in exchange for the opportunity to participate as a CSA Gardener, the following terms shall apply.

1. This CSA Gardener agreement begins _____, and is expected to continue through _____. Either part, however, may terminate this agreement at any time upon immediate notice, oral or written, to the other party.
2. The Gardener will perform services under the direction of the garden supervisor on duty for the day. The CSA gardener agrees to follow the directions of the garden staff and to abide by the **Garden Policies and Procedures**.
3. The CSA gardener agrees to assigned tasks in a responsible manner and to use care in all their actions and activities. It is the responsibility of the CSA gardener to let the garden staff know of any physical limitations as to what duties they cannot perform at the garden. The garden staff will honor those limitations in assigning tasks.
4. The CSA gardener is not an employee of the Garden and is not entitled to receive salary, benefits or other compensation other than what is stipulated in the Policies and Procedures of Auro Community Garden, LLC.
5. The CSA gardener understands that he/she does not qualify for worker’s compensation benefits and is expected to carry personal medical insurance to cover medical expenses for any injuries he/she may incur while performing garden services.
6. The parties agree this is the entire agreement and no agreement, oral or written, exists outside this agreement.

Release

CSA gardener agrees to hold self, heirs, assigns, and next of kin, releasing and agreeing to indemnify and hold harmless the Garden, its officers, employees, agents and representatives or others from any responsibility or liability for personal injury, including death, and damage or loss of property the Gardener may incur due to accidental occurrences while visiting the Garden or otherwise engaging in activities pursuant to the Agreement.
